NORTH SUSPENSION FOOTBRIDGE FOUNDATIONS AND REHABILITATION TENDER EVALUATION

From EXP, Amir Khalil, PMP, P.Eng. provided a tender analysis report on the North Footbridge rehabilitation. Due to the significant price increase, the Commission approved to defer the project for two years and, during that time, consult the community on the future of this project and get EXP to provide additional rehabilitation options.

CLEAN LAKE QUOTE

Clean Lake provided the Commission with a quote for a harvester rental. The costs include the following:

- Weekly price of \$5,000, plus HST (includes forty (40) operating hours)
- Additional fee of \$130 per hour for any additional hours over the forty (40) hours per week
- Maintenance cost of \$395, plus HST per week
- Training fee per driver (minimum of 2) of \$625, plus HST

The Commission approved to receive this as information.

BEACH RULES SIGN

Commission approved for two signs: a 20 x 30 pedestal sign at the south private beach and a 45 x 43 sign on two posts at the north private beach. These signs will be outlining beach rules through pictures and words with the following beach rules:

- Do Not Litter
- No Powered or Motorized Vehicles
- No Camping, Campfires or Barbecues
- No Ball or Frisbee Throwing at the Inconvenience of Others
- Observe and obey all Government Regulations Prohibiting Alcohol, Smoking, Vaping or Cannabis Use
- No Lifeguard on Duty
- No Dogs Allowed
- No Trespassing

MAINTENANCE CONTRACT

The Maintenance Contract tender was posted from February 1 to March 1, 2022. Staff received one quotation from Little Contracting. The Commission rejected the submission from Little Contracting and the RFQ will be reposted without the requirement of beach cleaning equipment.

AWARD - GRASS CUTTING CONTRACT

The Grass Cutting tender was posted from February 1 to March 1, 2022, and staff received three quotations: Forest Ridge Landscaping, Telford Property Management and Little Contracting. Commission approved to award the grass cutting contract to Telford Property Management from 2022 to 2024 for the following amounts:

- 2022 - \$575
- 2023 - \$595
- 2024 - \$625

AWARD - BEACH SECURITY CONTRACT

The Beach Security tender was posted from February 1 to March 1, 2022, and staff received Six (6) quotations: Garda World, OEIS Investigations, Neptune Security, Maxama Protection, Safestate Securities, Immediate Response Force. The Commission approved to award the Beach Security Contract to Safestate Securities for the Years 2022, 2023 and 2024 for the following prices:

- 2022 - \$162.50 per day, plus HST
- 2023 - \$167.50, per day, plus HST
- 2024 - \$172.50, per day, plus HST

AWARD - JANITORIAL SERVICES

The Janitorial tender was posted from February 1 to March 1, 2022, and staff received three (3) quotations: Jose Cardosa Kidron, Janitorial Sky Blue Services, Sheri Guest Cleaning Services. The Commission approved to award Sheri Guest Cleaning Services for Years 2022, 2023 and 2024 for the following prices:

- 2022 - \$70, plus HST per day
- 2023 - \$70, plus HST per day
- 2024 - \$70, plus HST per day

NEW HARVESTER & CONVEYOR COLOUR OPTIONS

The Commission was presented with a variety of colours for the harvester and conveyor. Due to feedback regarding repainting the current shore conveyor to a more non-conspicuous colour, staff is recommending to go to a Hunter Green or National Blue. Commission approved the Safety Orange colour for the new Harvester and the Forest Green for the new shore conveyor.

GOOSE MANAGEMENT SURVEY

The Commission received information that from March 1 to March 7, 87 respondents responded to the survey with 27 respondents willing to participate in a resident-formed and lead Goose Management Program Commission and 71 respondents willing to participate in an annual Goose Management Program. The survey is now closed. Thank you to the public for their participation.
