BYLAW NO. 2020.20

BEING A BYLAW TO AMEND FEES OR CHARGES BYLAW 2017.18

WHEREAS Section 391 of the Municipal Act, 2001, authorizes a municipality to impose fees or charges on persons,

- (a) for services or activities provided or done by or on behalf of it;
- (b) for costs payable by it for services or activities provided or done by or on behalf of any other municipality or any local board; and
- (c) for the use of its property including property under its control. 2006, c. 32, Sched. A, s. 163 (1).

AND WHEREAS Council passed Bylaw 2017.18 on March 27, 2017 to impose fees or charges for the Township of Ramara;


AND WHEREAS it is the desire of Council to further amend Schedule "B" of Bylaw 2017.18 to include fees and charges related to Short Term Rental Accommodation Licenses;

NOW THEREFORE, the Council of the Township of Ramara hereby enacts as follows:

1. **THAT** Schedule "B" of Bylaw 2017.18 be replaced with the attached Schedule "B".
2. **THAT** this Bylaw shall come into force and take effect on the date of passing.
