BYLAW NUMBER 2020.03

BEING A BYLAW TO ESTABLISH SALARIES AND HONORARIUMS (Council)

WHEREAS the Municipal Act, 2001, confers on municipalities the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS the Planning Act, R.S.O., 1990 confers the right to Council to establish compensation for the members of the Committee of Adjustment;

AND WHEREAS the Building code Act, S.O., 1992 confers the right to Council to establish compensation for the members of the Property Standards Committee;

AND WHEREAS the Line Fences Act confers the right to Council to fix rates for remuneration of fence viewers;

AND WHEREAS the Council of the Corporation of the Township of Ramara passed Bylaw 2014.90 for the purpose of establishing salaries and honorariums under the provisions of the Municipal Act, R.S.O. 1990;

AND WHEREAS the Council of the Corporation of the Township of Ramara desires to establish revised honorariums and salaries for the remuneration of its Members of Council, Committee of Adjustment, Emergency Management Committee, Property Standards Committee, Fence Viewers, Audit Committee, Livestock Investigators and Poundkeepers;

NOW THEREFORE, the Council of the Township of Ramara hereby enacts as follows:

1. **THAT** the salaries and honorariums of the Members of Council, Committee of Adjustment, Emergency Management Committee, Property Standards committee, Fence Viewers, Livestock Investigators, Audit Committee and Poundkeepers be in accordance with Schedule "A" attached hereto;
2. **THAT** this Bylaw shall come into force and effect on January 1, 2020.
