Council - May 29, 2023

Mayor Update

Mayor Clarke opened up the meeting and reported that he attended the 18th annual Ramara Chamber of Commerce Business Achievement Awards with other members of Council to recognize the valuable businesses in the community.

Bayshore Village Subdivision

The public meeting was held to consider a proposed municipally led Zoning by-law amendment to harmonize the provisions and permitted uses in the Township's Zoning By-law with the current requirements of the Bayshore Village Association. This Zoning By-law amendment would only affect the current Shoreline Residential 6 (SR-6) Zoning (Bayshore Village Subdivision Properties). Council approved for staff to return an updated Zoning By-law amendment to the next regular Council meeting with any new information and/or public comments received.

Council has amended the fireworks bylaw to ban the use of fireworks within the boundary area of Lagoon City. Outside of Lagoon City, a Fireworks permit is required, other than on specific holidays, in the following areas:

- Bayshore Village
 - All properties within the Township of Ramara that are zoned:
 - Shoreline Residential (SR)
 - Village Residential (VR)
 - Hamlet (H)
