



## **Couchiching OPP Detachment Board Recruiting Community Board Members**

With upcoming changes to the Community Safety and Policing Act, we are inviting applications from community members to join the newly-formed Couchiching OPP Detachment Board.

### **Board Composition**

The Board will include one elected official from each of the following municipalities, as well as 4 community members and 2 provincial appointees:

- City of Orillia
- Township of Oro-Medonte
- Township of Ramara
- Township of Severn

### **Eligibility**

To apply to become a Community Appointee, you must:

- Be an eligible elector in the City of Orillia or Townships of Oro-Medonte, Ramara or Severn
- Obtain a current and acceptable Criminal Record Check, at your expense, prior to appointment to the Board
- Successfully complete the following training:
  - Role of the OPP Detachment Board and responsibilities of members
  - Human rights and systemic racism
  - The diverse, multi-racial and multicultural character of Ontario society
  - The rights and cultures of First Nation, Inuit and Metis Peoples

You are not eligible if you are:

- A judge or justice of the peace
- A member of a police service, special constable, or a First Nation Officer
- Someone practicing criminal law (either defense or prosecution)
- A director, officer, or employee of any policing provider
- A former member of a police services unless:
  - The OPP Detachment Board does not maintain a police service that the person was a member of; and
  - At least one year has passed since the person ceased to be a member of any police service.

If you live in one of these communities and would like to support community wellbeing, we invite you to apply to join the board. Experience in local government and/or serving on agencies, boards and committees is considered an asset.

Appointees to the Board will receive compensation at a per-diem rate and will be reimbursed for travel mileage to and from meetings. This opportunity offers a chance to actively participate in shaping local law enforcement and safety initiatives. The City of Orillia is managing the intake of all applications for the Couchiching OPP Detachment Board. Following completion of the interview and selection

process, each member municipality will be appointing its own community member to the Board.

Please note that any successful applicants will be required to complete required training and obtain a criminal record check.
