NOTICE OF COMPLETE APPLICATION AND PUBLIC MEETING CONCERNING A PROPOSED ZONING BYLAW AMENDMENT

TAKE NOTICE that the Corporation of the Township of Ramara received an application on August 30, 2022 and was considered a complete application on August 30, 2022, for a Zoning Bylaw Amendment for the land described as the Part of Lot 11, Concession 4, Mara, being Part 1, Plan 51R-13648, known municipally as 2362 Highway 12.

TAKE NOTICE that the Council of The Corporation of the Township of Ramara will hold a public meeting on MONDAY OCTOBER 31, 2022 @ 9:30 A.M. being a Hybrid Meeting, on the Zoom platform and in person in the Council Chambers, to consider a proposed Zoning Bylaw Amendment, pursuant to Section 34 of the Planning Act, R.S.O. 1990, c.P.13. The meeting will be posted to the Township's You Tube Channel once completed. Please advise the Township of your email address so an invitation to join the public meeting can be sent to allow the public the opportunity to speak at the meeting.

THE PROPOSED Zoning Bylaw Amendment will have the effect of amending the current zoning from Village Industrial Exception One (VID-1) to Village Commercial (VC), allowing more flexibility to the uses within the Village of Brechin.

ANY PERSON may make written representation either in support of, or in opposition to, the proposed Zoning Bylaw Amendment. Signed, written submissions will be accepted by the Clerk prior to the meeting. Written submissions can be sent electronically to jconnor@ramara.ca, can be dropped in the mail drop box at the Township Administration Centre at 2297 Highway 12, Brechin or faxed to (705) 484-0441. Please ensure your name and address are included as required for the public record.

IF YOU WISH to be notified of the adoption of the proposed Zoning Bylaw Amendment, you must make a written request to the Clerk of the Township of Ramara, Box 130, Brechin, Ontario, L0K 1B0.

IF A PERSON or public body does not make written submissions to the Township of Ramara before the proposed Zoning Bylaw Amendment is adopted, the person or public body is not entitled to appeal the decision of the Council of the Township of Ramara to the Ontario Land Tribunal (OLT).

IF A PERSON or public body does not make written submissions to the Township of Ramara before the proposed zoning bylaw amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal (OLT) unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.
