

## **THE CORPORATION OF THE TOWNSHIP OF RAMARA**

### **BYLAW NO. 2024.66**

#### **A BYLAW TO NAME OR CHANGE THE NAMES OF VARIOUS HIGHWAYS WITHIN THE TOWNSHIP OF RAMARA**

**WHEREAS** the Municipal Act, R.S.O. 2001, Chapter M45, Section 61 provides that a municipality may, at any reasonable time, enter upon land lying along a highway to install and maintain a sign setting out the name of a highway;

**AND WHEREAS** the Municipal Act, R.S.O. 2001, Chapter M.45, Section 116 provides that a municipality may establish, maintain and operate a centralized communication system for emergency response purposes;

**AND WHEREAS** the Council of the Township of Ramara desires to rename certain highways within the Township of Ramara to alleviate duplication and confusion with respect to certain highways;

**NOW THEREFORE, the Council of the Corporation of the Township of Ramara hereby enacts as follows:**

1. THAT the following highways be renamed accordingly:

Concession Road 8	East of Muley Point Road	Duplication of Concession Road 8 intersecting Highway 12 and County Road 169	Barnstable Drive

Concession Road 8	Unnamed portion, at the intersection of Concession Road 8 and Sideroad 20	Unnamed road allowance that contains a road	Four Jay Way
Concession Road 9	East of Muley Point Road	Duplication of Concession Road 9 intersecting Highway 12	Ross Road
Concession Road 12	East of Sideroad 5	Duplication of road name for three (3) segments	Klondike Road
Concession Road 12	West of Fairvalley Road to County Road 169	Duplication of road name for three (3) segments	Cahill Road
Concession Road 12	West of Kirkfield Road	Duplication of road name for three (3) segments	Sajnovic Place
Concession Road 13	West of Kirkfield Road	Duplication of Concession Road 13 west of County Road 169	Mundy's Lane
Sideroad 15	South of Concession Road A	Duplication of Sideroad 15, north of Concession Road 7	Muir Road
Sideroad 20	South of Concession Road 8	Duplication of Sideroad 20, north of Concession Road 9	Barnstable Drive

2. THAT any previous bylaws referencing the current road names as noted above are deemed to be repealed.

3. THAT this Bylaw shall come into force and take effect on the date of passing.
